壹、活動緣起

現今對社會造成威脅的因素正逐步加深,實質衝突與經濟競爭所造成嚴重後果日益複雜,更重要的是「貪腐」所造成之危害,除實質減損政府機構功能外,尚可能挾持統治階層並非法影響政府決策,造成不必要資源浪費。「聯合國反貪腐公約」序言,開宗明義即要求「關注『貪腐』對社會穩定及安全,所造成問題與構成威脅之嚴重性,包含破壞民主體制、價值觀、道德觀及正義,並且危害永續發展與廉能法治」。

當貪腐事件發生於國防部門中,伴隨而來的是國家安全的威脅性、社會信任的分裂性及預算資源浪費性等嚴重影響,我國國軍體察廉潔肅貪之趨勢與必然性,先於 102 年編成「總督察長室」與「政風室」以複式布網方式強化國軍肅貪、防貪能量,更於 109 年編成法律事務司法紀調查處,扎根行政調查基礎職能,俾利落實政府清廉政策、提升國軍廉能形象;其中業管廉政事務推動單位「政風室」下轄除辦理政風業務相關之綜合科、預防科及查處科等科別,並編有廉評小組專責全球「政府國防廉潔指數」評鑑相關事務(負責國際交流、評鑑整備、澄復及執行學術研究等業務)。

國際透明組織於 102 年發布「政府國防廉潔指數」,係針對各國國防部門中政治領域、財務領域、人事領域、軍事

行動領域及採購領域等進行風險評比,檢視既有運作流程問題及資訊透明公開程度,有效減少潛在貪腐因素肇生,提升國防事務監督效力;評鑑結果顯示我國在全球 82 個參與評鑑的國家中,與英、美等先進國家齊列 B 級,屬於前 11%之低度貪腐風險國家;嗣 104 年公布第二次評鑑,全球 114 個受評鑑國家中,我國與澳洲、加拿大、德國、日本、新加坡等國並列 B 級,顯示我國國防廉政運作機制與施行成效持續受到國際社會肯定;110 年公布第三次評鑑中,在全球 86 個受評國家中,我國連續三屆蟬聯 B 級之佳績;同時,也是亞洲地區唯一擠進前 10 名的國家,在現行艱困國際環境下,還能取得如此佳績,表示國軍推動廉政建設成果已深獲國際肯定,也大幅提升民眾對國軍的信賴與支持。

另依據我國聯合國反貪腐公約第二次國家報告國際審查結論性意見,國際審查委員再次聚焦於我國企業反貪腐議題;為傳達我國重視企業誠信、法令遵循與積極推動國防產業合作、完善管理機制之目的,爰於本次論壇規劃「廉能國防企業誠信」研討場次,以國防相關產業鏈之本國廠商、外商及跨國企業人士為邀請對象,透由產、官、學、研等各界資訊交流,傳達學界觀點與國際趨勢外,並邀請致力於法遵實務與永續發展之優良企業分享經驗;並由公私部門代表進行研討座談,廣泛交換意見凝聚共識,期促進我國廉政政策的推展與公私部門的互動,協力共創誠信治理的關鍵價值,

以提升產業及國家競爭力。

鑒於「貪腐已不再是地方性及單一領域的問題,而是一種影響所有社會和經濟之跨國現象,因此,進行國際合作以預防及控制貪腐,乃至關重要」;本部自 103 年起逐年籌辦國際廉政學術及參訪活動,並於本(111)年 12 月 7 日賡續邀請國際廉政專家與國內學者展開學術交流活動,期透過學術與實務之交流對話,落實非正式外交的國際軍事互動,策勵國軍推展廉政效能與未來願景。以下分為「活動沿革」、「論壇概述」及「預期效益」3 大部分介紹本次論壇活動:

一、背景沿革

國防部參與國際透明組織推出的「政府國防廉潔指數(Government Defence Integrity Index, GDI)」評鑑已邁向第 10 個年頭,除評鑑各題項內容相關整備外,自 102 年起政風室每年皆舉辦國防廉政學術交流活動,邀請國內、外廉政相關學者專家,針對「評鑑整備」、「廉潔教育」及「廉政政策」等相關議題進行學術面與實務面剖析探討。

在學術交流過程中,提供我國對於「解讀 GDI 評鑑成績」、「掌握未來評鑑走向」深入瞭解外,更能向標竿國家學習,強化我國在「亞洲地區國防廉政的潛在優勢」及型塑「亞太地區軍事廉政學術重鎮」的核心角色,讓學術與實務進行對話交流,使我國軍事廉政事務的推動與國際脈絡接軌,提升

國軍廉能國際化視野並充分落實評鑑精神。

下表為歷年國防廉政學術交流活動摘要說明,從歷次評鑑引用相關資料中,可發現多數來源為學術期刊、媒體報導及公開相關資料,透過學術研討會、工作坊及會議論壇等學術活動辦理模式能有效、快速地將國軍廉政相關作為進行系統化耙梳與綜整,並能適時引進外界建言,進行即時性政策建議與修正,有助強化評鑑整備資料公信力。

例如以110年所舉辦「國軍廉潔教育實踐與創新論壇」, 邀集政策相關業管單位、執行單位(各軍校院校)及外部專家 學者能有效針對現行廉潔教育所面臨推動窒礙,進行對話交 流,提供政策興革方向,有利於國軍廉潔政策初衷落實與作 為第4次評鑑整備潛在優勢項目。

二、論壇概述

為營造本部參加第 4 次政府國防廉潔指數(GDI)評鑑佳績及強化企業誠信、杜絕賄賂公務員之目的,規劃舉辦「國防廉政國際學術論壇」活動,邀請國際廉政專家以「視訊方式」與會,結合國內學者共同就「軍事廉潔評鑑指標革新」及「廉能國防企業誠信」等相關議題,透過專題演講、國防廉政議題研討與實務經驗分享等接軌國際的學術交流方式,吸引國際社會的支持與正視,形塑我國國防廉政學術與施政成效為亞洲地區標竿的正面形象,俾利再次爭取國際廉潔評鑑佳績的肯定。

鑑於確保高科技產業競爭力及國家安全已為國際重要 趨勢,本次論壇上午議程以「國家安全與核心研發能力之保 護」及「企業誠信治理與法律遵循」為主軸,邀請國內廉政 專家學者及國防科技領域之優良企業進行「專題演講」與「企 業經驗分享」,並邀集專家學者、企業界就「企業誠信治理 與法律遵循」、「核心技術安全管制」及「營業秘密保護」等 議題進行綜合座談,並與現場與會來賓意見交流,激盪多元 思維,藉以促進公私部門對話機會,強化國防產業良善治理 與國防科技營業秘密保護,型塑各界雙贏契機。

下午議程則以「軍事廉潔評鑑指標革新」為主軸,邀請國際透明組織成員及國內廉政專家學者,透過「專題演講」

及「議題討論」等方式,以「實踐國防廉能治理新典範」為 題實施專題演講外,另針對「第 4 次 GDI 評鑑指標設計與變 革」及「各國參與評鑑作法標竿學習」等議題深入研討,讓 學術與實務進行對話交流,使我國軍事廉政事務的推動與國 際脈絡接軌,並持續努力成為亞太地區國防廉政領頭羊,帶 領各國的國防廉政。

三、預期效益

(一)善用軍事廉政平臺、營造非正式外交亮點

本部自 102 年起逐年邀請英、日、韓、新加坡、紐西蘭 等國際廉政學者來臺參加軍事廉政學術交流活動,除能近距 離認識我國優質的國防透明度與廉政建設,同時透過「政府 國防廉潔指數」評鑑專案所建構的軍事廉政平臺,展現我國 與國際接軌的廉政軟實力,適度輔助正式官方外交關係上的 侷限。

(二)分享 GDI 佳評經驗、行銷臺灣清廉價值

我國參加 政府國防廉潔指數」全球評鑑,三度獲得 B」等級殊榮,尤以 2021 年第三次評鑑與德國同分,獲得國際排名全球第六名、亞洲地區唯一維持「B」等級國家的成就高峰。藉由邀請國際廉政學者視訊參加的機會,分享籌辦受評過程的經驗與成就,適度行銷我國政府的清廉價值。

(三)建立雙向溝通管道、維繫客觀評鑑佳績

本部參加歷次「政府國防廉潔指數」評鑑中,發現相同的國防組織架構、任務與運作機制,因不同的評核人個人主觀意識,形成極大的得分差異,為維繫 114 年 (2025 年) 第4 次全球評鑑的客觀評鑑環境,規劃國際廉政專家視訊方式參與建立國防廉政的透明、課責機制,建立雙向溝通管道,掌握最新評鑑資訊,適時釐清評鑑疑慮,避免評核人個人主觀意見,斲傷國軍廉能施政成績。

(四)落實國防廉能誠信、厚植國防創新能量

遵從「聯合國反貪腐公約」及「國家廉政建設行動方案」 之廉政策略方針,推動強化主管責任、行政透明等具體作為, 深化企業誠信透明及落實法令遵循觀念;同時行銷本部推動 國防產業鏈、強化自主國防之願景及成果,朝向「培養產業」、 「軍民通用」及「環保綠能」之優質國防科技推展。

(五)營造公私協力場域、共創廉能永續治理

對外說明本部近年推動國防產業升級、企業投資透明化、 科技研發保護級管理等革新措施,以及本部與企業間誠信合 作之理念與實務作為,期透過公私協力共創優質經營環境, 維繫廉能堅實的國防戰力,建立互利雙贏的永續治理關係。

肆、研討摘要

本次「國防廉政國際學術論壇」活動,主軸區分為「廉 能國防企業誠信」及「軍事廉潔評鑑指標革新」等2場次議 題研討,議程內容包含專題演講、議題研討及綜合座談等, 以下針對各場次資訊及研討議題依序進行介紹。

一、「廉能國防企業誠信」研討場次 (一)場次簡介

本場次區分為「專題演講」、「企業經驗分享」及「綜合 座談」意見交流等3大議程。

在「企業經驗分享」中,邀請漢翔航空工業(股)公司公關法務處處長周峻講授「從法令遵循推動企業誠信與永續發展」,分享漢翔公司落實誠信經營、重視法遵之具體作法及相關效益。

在「綜合座談」議程中,由國立陽明交通大學特聘教授 林志潔講授擔任主持人,邀集行政、司法主管機關、專家學 者及企業部門擔任與談人,深入探討「誠信治理與法律遵循 對企業永續經營之重要性」、「國防先進科技安全管制作業」 及「國防產業營業秘密之保護與管理」等議題。

在「各國參與評鑑作法標竿學習」議程中,邀請由國內、 外專家學者擔任與談人,並分享「評鑑策進建議」及「我國 評鑑不適用題項及策進」等議題。

(二)專題演講說明

1.主題介紹

「專題演講」主題將聚焦於「實踐國防廉能治理新典範」範疇,開宗明義介紹國防貪腐可能造成之危險、分裂與浪費,並說明國防反貪腐之重要性、如何降低軍事行動中的貪腐風險等資訊,並提出相關建議事項,接著說明政府國防廉潔指數評鑑目的、方法與延伸運用,藉以強化各級部隊軍事事務貪腐風險管理與危機處理的應變能力,防範軍風紀與貪腐案件肇生,維護軍隊廉能形象,爭取公民社會認同,營造融洽的軍民關係。

I. Activity Introduction

The factors that currently threatening society are gradually worsening, and the consequences of both real conflicts and economic competition are increasingly complex. More importantly, the harm caused by "corruption" may not only substantially impair the functioning of government institutions, but also taint the government hierarchy and illegally affect government decisions, resulting in the unnecessary waste of resources. The preamble of the United Nations Convention against Corruption specifically requires countries "to pay attention to the seriousness of the problems and threats posed by" corruption "to social stability and security, including the destruction of democratic institutions, values, ethics and justice, and the harm to sustainable development and integrity and the rule of law."

When corruption occurs in the national defense sector, it is accompanied by threats to national security, the fragmentation of social trust, and the waste of budgetary resources. Aware of anti-corruption trends and the necessity of anti-corruption measures, our armed forces first established a "the Inspector General Office" and "Government Ethics Office" in 2013 to strengthen the armed forces' anti-corruption and corruption investigation capabilities through the establishment of a dual network. In 2020, the armed forces' anti-corruption arm was

re-organized as an office of judicial discipline and investigation under Department of Legal Affairs, which is responsible for strengthening the basic functions of administrative investigation goal of implementing the and has government's anti-corruption policy and enhancing the armed forces' image of integrity and competence. In particular, the "Government Ethics Office," which is a business affairs anti-corruption promotion the ethics-related unit, jurisdiction over General Administration Section, Prevention Section, and Investigation and Handling Section, and has an integrity assessment team dedicated to the assessment of the global "Government Defence Integrity Index" (responsible for international exchanges, clarification academic assessment and preparation, and research).

The Transparency International first announced the "Government Defence Integrity Index (GDI)", GDI assesses the quality of institutional controls to manage the risk of corruption in defence and security institutions. The team of experts draws together evidence from a wide variety of sources and interviewees across 77 areas(five key corruption risk areas: financial, operational, personnel, political, and procurement), with the goal of producing a detailed assessment of the integrity of national defence institutions(TI-DS, 2021).

In 2013, among the 82 countries participating in the evaluation, Taiwan was ranked on Level B, along with the

United Kingdom, the United States, and other advanced countries, and was among the top 11% countries with low corruption risk. The results of the second evaluation was published in 2015. Among the 114 evaluated countries, Taiwan, Australia, Canada, Germany, Japan, Singapore, and other countries were ranked on Level B, which shows that the effectiveness of Taiwan's military integrity operating mechanisms and implementation has been recognized by the international community. According to the results of the third evaluation, which were issued in 2021, among the 86 countries assessed, Taiwan was ranked Grade B for a third consecutive time. At the same time, it is also the only country in Asia to be ranked in the top 10. In the current difficult international environment, the fact that Taiwan can still achieve such good results indicates that the achievements of the armed forces in promoting the maintenance of clean government have been deeply recognized by the international community, and have also greatly enhanced the people's trust and support for the armed forces.

In addition, according to the concluding comments of the international review of the second national report of the United Nations Convention against Corruption, the international review committee once again focused on the anti-corruption issues concerning R.O.C enterprises. To emphasize Taiwan attaches great importance to enterprise integrity, compliance with laws

and regulations, the active promotion of cooperation in the defense industry, and the improvement of management mechanisms, this forum plans to hold a seminar on "business integrity," which will invite domestic manufacturers, foreign businessmen, and transnational enterprises in defense-related industry chains to exchange information. At this seminar, persons from all walks of life, including industry personnel, officials, university professors, and researchers, will discuss their academic views and international trends. In addition, outstanding enterprises committed to good legal compliance practices and sustainable development have been invited to share their experiences, and representatives of the public and private sectors will hold discussions, exchange views, and build consensus. The seminar will consequently serve to promote Taiwan's Integrity government policy and effective interaction between the public and private sectors, which can work together to create the key value of honest governance, which will enhance the competitiveness of the industry and the country.

Considering that "corruption is no longer a local or single area problem, but a transnational phenomenon that affects all societies and economies, international cooperation to prevent and control corruption is essential, "since 2014, the Ministry has been organizing yearly academic and visit activities on international integrity. It has therefore invited international anti-corruption experts and domestic scholars to carry out

academic exchange activities on December 7 of this year (2022), with a view to implementing international military interchange via informal diplomacy consisting of academic and practical exchanges and dialogues. This activity will also encourage the armed forces to promote anti-corruption and highlight its future vision. The forum is further discussed in the following "Event Background," "Forum Overview" and "Expected Benefits" sections.

1. Event Background

The Ministry of National Defense has participated in the evaluation of the "Government Defence Integrity Index (GDI)" introduced by the Transparency International, and which is now in its 10th year. In addition to the preparation of evaluation items, the Government Ethics Office has held an academic exchange activity on Military integrity every year since 2013. Domestic and foreign scholars and experts invited to these events analyzed and discussed the academic and practical aspects of "integrity education," "integrity policy," and other related issues.

In the process of academic interchange, we hope not only that our country will obtain a deep understanding of "interpretation of GDI evaluation results" and "mastering future evaluation trend," but also learn from the benchmark countries, strengthen our core role in "the potential advantages of military

integrity in Asia" and shaping "the academic center of military integrity in the Asia Pacific region." Other goals include fostering academic and practical dialogue and exchange, ensuring that our military integrity affairs are aligned with the international context, enhancing the international vision of the armed forces and fully implementing the GDI evaluation spirit.

The following table is a summary of academic exchange activities concerning military integrity over the years. From the materials cited by the previous evaluations, it can be found that most of the sources consisted of academic journals, media reports, and relevant public materials. Through academic seminars, workshops, conferences, forums, and other academic activities, we can effectively and quickly summarize the integrity-related activities of the armed forces, and can introduce external advice and timely policy suggestions and revisions that will help strengthen the credibility of the evaluation readiness data.

For example, the "National Military Integrity Education Practice and Innovation Forum" held in 2021 invited policy-related business management units, implementation units (military schools and colleges), and external experts and scholars to engage in dialogue and interchange. The participants at this event discussed the obstacles faced by current integrity education, and provided directions for policy reform. The results of the event facilitate derealization of the original intentions of

the national military integrity policy and served as potentially advantageous items in the fourth evaluation.

This event was a pioneering effort to promote military integrity education in the Asia Pacific region.

2. Forum Overview

In order to build on the Ministry's participation in the fourth Government Defence Integrity Index (GDI) evaluation, strengthen corporate integrity, and eliminate bribery by civil servants, the Ministry plans to hold the "Taiwan International Academic Forum on Military Integrity." International integrity experts will be invited to participate in the conference via videoconferencing, and will engage in discussion with domestic scholars concerning such relevant issues as "innovation in the military integrity evaluation index" and "integrity of honest and capable defense enterprises" through keynote talks. discussion of military integrity issues and the sharing of practical experience will attract the support and recognition of the international community, enhance the positive image of integrity academic Taiwan's military and governance achievements as a benchmark in Asia, and help the country to again earn a high ranking in the international integrity assessment.

Since ensuring the competitiveness of high-tech industries and national security has become an important international trend, the morning agenda will focus on "national security and the protection of core R&D capabilities" and "corporate integrity governance and legal compliance." Domestic integrity experts and scholars and excellent enterprises in the field of

defense technology will be invited to give keynote speeches and share enterprise experience, and experts and scholars will have opportunities to engage in discussion. The business community will also hold a general discussion on issues such as "corporate integrity governance and legal compliance," "core technology security control" and "business secret protection," and exchange views with participants. This will stimulate diversified thinking, promote opportunities for dialogue between the public and private sectors, strengthen good governance in the national defense industry and protection of national defense technology business secrets, and foster win-win opportunities for all sectors.

In the afternoon, members of transparency international and domestic integrity experts and scholars will be invited to give keynote speeches on "The Trends and Challenges of GDI," which will be followed by discussions. In addition, in-depth discussions will also be held on topics such as "The changing of the Fourth GDI" and "Benchmark Learning from Countries' Participation in Assessment Practices." Academic and practical dialogue and exchange will help align the promotion of military integrity affairs in Taiwan with the international context, and will strengthen Taiwan's efforts to maintain its military integrity leadership in the Asia Pacific region.

3. Expected Benefits

(1) Making good use of the military integrity platform and creating points of light through informal diplomacy

Since 2013, the Ministry has invited international integrity scholars from the United Kingdom, Japan, South Korea, Singapore, New Zealand, and other countries to Taiwan to participate in military integrity academic exchange activities. In addition to getting a better understanding of t Taiwan's outstanding national defense transparency and integrity building efforts, the Department has also demonstrated the Taiwan's soft power of integrity in line with international standards through the military integrity platform established through the "Government Defence Integrity Index" evaluation program, and appropriately helped ease the constraints on formal official diplomatic relations.

(2) Sharing Taiwan's outstanding GDI evaluation experience and marketing Taiwan's anti-corruption value

Taiwan has participated in the global assessment of the "Government Defence Integrity Index" and won "B" level honors three times. In particular, in the 2021 third assessment, Taiwan had the same score as Germany, received sixth place in the international ranking, and had the fine achievement of being the only country to stay at a "B" level in Asia. By inviting

international integrity scholars to participate in the video conference, we will share the experience and achievements of preparing for the evaluation, and appropriately market the anti-corruption value earned by our government.

(3) Establishing two-way communication channels and maintaining objective evaluation of achievements

In all previous "Government Defence Integrity Index" evaluations, the Ministry found that the same defense organizational structures, tasks, and operating mechanisms had significant differences in scores due to different reviewers' individual subjective views. In order to maintain an objective evaluation environment during the fourth global evaluation in 2025, the Department plans to participate in the establishment of a transparency and accountability mechanism for military through videoconferencing among integrity international integrity experts. The Department also plans to establish two-way communication channels, acquire the latest evaluation information, promptly clarify any evaluation questions, and ensure that subjectivity on the part of reviewers does not obscure the integrity of the armed forces.

(4) Implementing national defense anti-corruption and integrity, and cultivating national defense innovation capability

In compliance with the integrity policy of the United Nations Convention against Corruption and the National Action Plan for Building an Incorruptible Government, the Department will promote the strengthening of executive responsibility, administrative transparency and other specific actions, deepen the integrity and transparency of enterprises and reinforce compliance with laws and regulations. At the same time, we will market the Ministry's efforts to build a defense industry chain, strengthen the vision and achievements of the ROC's independent national defense, and promote high-quality national defense technology based on cultivation of industry, military and civilian use, and environmental protection and green energy.

(5) Creating an environment fostering public-private cooperation and jointly fostering honest and competent sustainable governance

We will explain to the outside world how the Ministry has taken innovative measures in recent years to promote the upgrading of national defense industry, transparency of enterprise investment, management of the protection of scientific and technological research and development, as well as the concept and practice of honest cooperation between the Ministry and enterprises, with a view to creating a high-quality business environment through public-private cooperation, maintaining an honest and effective national defense force, and establishing mutually beneficial win-win sustainable governance relationships.

IV. Summary

This "International Academic Forum on National Defense and Integrity" activity will focus on the two discussion topics of "Business Integrity in Defense Sector" and "Innovation in Government Defence Integrity Index," and the agenda will include keynote speeches, the two seminars, and general discussions. The topics of each seminar and related information are introduced below.

1. Seminar on "Business Integrity in Defense Sector"

(1) Session introduction

This session will include the three agenda items of the keynote speech, enterprise experience sharing, and general discussion.

In her keynote speech, Carol Lin, a distinguished professor at NYCU, will give a talk on "National Security and Protection of Core R&D Capabilities," which will emphasize the importance to national security and enterprise competitiveness of business secret protection in high-tech industries.

In enterprise experience sharing period, Chun Chou, Director, Public Relations and Legal Affairs, Aerospace Industrial Development Corporation, will give a talk on "Promoting Business Integrity and Sustainable Development through Compliance with Laws and Regulations," and will share specific practices and related benefits of business integrity implementation and emphasis on legal compliance.

In the general discussion, Carol Lin, Distinguished Professor, National Yang Ming Chiao Tung University, will be the moderator, and administrative and judicial authorities, experts and scholars, and enterprise personnel will be invited to participate in the discussion. This discussion will cover such issues as "the importance of integrity governance and legal compliance for the sustainable operation of enterprises," "advanced national defense technology security control operations," and "the protection and management of business secrets in the national defense industry."

(2) Keynote speech

1. Introduction to the topic

The keynote speech will focus on the relationship between corporate integrity and corporate governance, suggest how the public and private sectors can practice anti-corruption measures, encourage healthy competition among enterprises, and ensure the sustainable operation of the industry. It will also cover how to build an effective hierarchical protection system for business secrets concerning key national technologies, strengthening protection strategies for industries and technologies in Taiwan, and how to work together to achieve the goals of ensuring the

development of the technology industry, maintaining the competitive advantage of enterprises, and enhancing the nation's economic vigor.

(3) Private sector experience sharing

1. Introduction to topic

The Aerospace Industrial Development Corporation has been actively promoting corporate governance, development of a sustainable environment, and maintaining social welfare for a long time. Based on the company's integrity management policy, and in compliance with laws and regulations, the Board of Directors and the business management departments do not engage in specific improper practices and related benefits such as accepting bribes, kickbacks, etc., and emphasize the importance of compliance with integrity laws to the sustainable operation of the enterprise.

2. Seminar on Innovation in the Government Defence Integrity Index

(1) Session introduction

This session is divided into the three major agendas items of keynote speech, the "Design of the Fourth GDI Evaluation Indicators and Changes" discussion topic, and the "Benchmark Learning for Countries to Participate in Evaluation Practices" discussion topic.

In the keynote speech, Chung-Li Wu, of Academia Sinica will serve as the moderator, and Transparency International – Defence & Security Programme Director Ms. Josie Stewart will give a keynote speech (in the form of a pre-recorded video) on the topic of "Practice a Paradigm of Integrity Governance of Military" to representatives of units responsible for the Ministry of Defense's "Government Defence Integrity Index Evaluation" and academic officers of the National Defense University as a

means of sharing current government defence integrity trends and challenges.

In the agenda item of the "Design of the Fourth GDI Evaluation Indicators and Changes," Mr. Michael Ofori-Mensah, the director of the government defence integrity index evaluation for the Defense Security Group of the Transparency International, will introduce the topic of "Design of Evaluation Indicators for the Government's National Defence Integrity Index," and domestic and foreign experts and scholars will serve as panelists in an in-depth discussion of such issues as "future evaluation reforms" and "inapplicable issues and policies in Taiwan's evaluation."

In the agenda item of "Benchmark Learning from Countries' Participation in Evaluation Practices," and experts and scholars from Taiwan and abroad will participate in sharing on "benchmarking practices for national assessment," "future policy actions," and other topics.

(2) Keynote Speech

1. Introduction to the topic

The theme of this keynote speech will be "GDI Government Defence Integrity Trends and Challenges," which will introduce the risks, divisions and waste that may be caused by national defense corruption, explain the importance of national defense anti-corruption work, how to reduce the risk

of corruption in military operations, put forward relevant suggestions, and then explain the purpose, method, and broad application of the Government Defence Integrity Index Evaluation. The ultimate goals of this work is to strengthen military affairs corruption risk management and crisis management of military units at all levels, prevent the emergence of military discipline and corruption cases, maintain the image of the armed forces for integrity, win the recognition of evaluation experts, and again win recognition in international integrity evaluations.

(3) Agenda 1: Design Changing of the Fourth GDI

1. Introduction to the topic

In the agenda item of "Design of the Fourth GDI Evaluation Indicators and Changes," the participants will discuss future changes in the content of the evaluation index, the scoring basis and testing steps, and share relevant experience from this evaluation in Taiwan. This will include a discussion of methodology (identification of scoring criteria, avoidance of too uniform scoring mechanisms, review of the reliability and validity of evaluation items, provision of relevant opinions concerning peer review, and discussion of items inconsistent with national conditions) a discussion of indicator items(scoring

logic and scoring benchmarks), and finally the provision of relevant practical suggestions, as follows:

- (1) Evaluation feedback from various countries should be broadly gathered and absorbed, and indicator feedback and discussion of innovations provided.
- (2) In response to the Ukrainian-Russian War and the situation in the Indo-Pacific region, a new item of military action should be added.
- (3) Considering the differences in culture and the strategic situations of different countries, design a self-organized feature evaluation project.

(4) Agenda 2: Benchmark learning from countries' participation in evaluation

1. Introduction to the topic

In the agenda item of "Benchmark learning from other countries' participation in evaluation practices," the topic of "national trends in military integrity evaluation" will serve as an introduction, and foreign guests will be invited to share "how to promote national government integrity" and "relevant practices in response to evaluation readily" based on the current practices of their countries. This will provide the Department with active
